A BILL FOR AN ACT

To amend State Law No. 8-171, Section 3, to reduce the amount appropriated to the Legislature for representation funds by \$14,000 and to appropriate the amount of \$14,000 to fund the operations of the four municipal governments in the State of Kosrae; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this act is two-fold, which is to reduce the amount
2 appropriated to the Legislature for representation funds by \$14,000 and to appropriate the amount of
3 \$14,000 to fund the operations of the four municipal governments in the State of Kosrae.

4 Section 2. Amendment. State Law No. 8-171, Section 3 is amended to read as follows:

5 "Section 3. Appropriation. Operation of the Legislature. The sum of \$409,081 395,081,
6 or so much thereof as may be necessary, is appropriated from the Revenue Fund; the sum of \$30,000 or
7 so much thereof as may be necessary, is appropriated from the United State Grant Fund of the Kosrae
8 State Treasury for the operation of the Legislature for the fiscal year ending September 30, 2007.

9 Section 4. Apportionment. Operation of the Legislature. The sum appropriated by
10 Section 3 of this act are apportioned as follows:

11	(a)	Personnel	-0-	271,281	-0-
12	(b)	Travel	-0-	50,000	-0-
13	(c)	Contractual	30,000	24,800 <u>10,800</u>	-0-
14	(d)	Others	-0-	63,000	-0-
15	(e)	Fixed Assets	-0-	-0-	-0-

16 Section 3. Appropriation. The sum of \$14,000.00 is hereby appropriated from the Local
17 Revenue Fund of the Kosrae State Treasury, for the purpose of funding the operation of the four
18 municipal governments in the State of Kosrae.

19 Section 4. Apportionment. The sum appropriated by Section 3 of this act is apportioned as
20 follows:

21	Lelu Town Government	\$4,000.00
22	Tafunsak Municipal Government	4,000.00

1 Section 5. Allottee. All funds appropriated by this act shall be allotted, managed, administered
 2 and accounted for in accordance with applicable laws. The allottee of the fund appropriated by this act
 3 shall be the Governor of the State of Kosrae who shall be responsible for ensuring that these funds, or
 4 so much thereof as may be necessary, are used solely for the purpose specified in this act and that no
 5 obligations are incurred in excess of the sum appropriated.

6 Section 6. Effective Date. This act takes effect upon the approval of the Governor or upon its
 7 becoming law without such approval.
