
A BILL FOR AN ACT

To appropriate the sum of \$353,177 from the Revenue Fund of the Kosrae State Treasury for the purpose of supplementing the operations of certain governmental entities for the fiscal year ending September 30, 2007; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$353,177 is hereby appropriated from the
2 Revenue Fund of the Kosrae State Treasury for the purpose of supplementing the operations of
3 certain governmental entities for the fiscal year ending September 30, 2007.

4 Section 2. Apportionment. The sum appropriated by Section 1 of this act are
5 apportioned as follows:

20 Section 3. Allottee. All funds appropriated by this act shall be allotted, managed,
21 administered, and accounted for in accordance with applicable laws. The allottee of funds
22 appropriated and apportioned under subsections (1), (2), (3), and (8) of Section 2 shall be the
23 Governor of the State of Kosrae; the allottee of funds appropriated and apportioned under
24 subsection (4) of Section 2 shall be the Speaker of the Kosrae State Legislature; the allottee of
25 funds appropriated and apportioned under subsection (5) of Section 2 shall be the Chief Justice

1 of the Kosrae State Court; the allottee of funds appropriated and apportioned under subsection
2 (6) of Section 2 shall be the Chairman of the Kosrae Broadcast Authority; the allottee of funds
3 appropriated and apportioned under subsection (7) of Section 2 shall be the Chairman of the
4 Kosrae State Scholarship Board. All allottees shall be responsible for ensuring that these funds,
5 or so much thereof as may be necessary, are used solely for the purpose specified in this act, and
6 that no obligations are incurred in excess of the sum appropriated. The authority of the allottees
7 to obligate funds appropriated by this act shall lapse as of September 30, 2007.

8 Section 4. Effective Date. This act takes effect upon the approval of the Governor or
9 upon its becoming law without such approval.
