

A BILL FOR AN ACT

To amend State Law No. 9-21, at Section 1 and Section 2, to supplement the operation of the Kosrae State Legislature, Office of the Governor and the Kosrae State Court for the fiscal year ending September 30, 2007; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this act is to appropriate money from the Foreign
2 Assistance Fund of the Kosrae State Treasury to supplement the operation of the Legislature,
3 Office of the Governor and the Kosrae State Court.

4 Section 2. Amendment. Section 1 and 2 of the Kosrae State Law No. 9-21 are hereby
5 amended to read as follows:

6 “Section 1. Appropriation. The sum of \$423,455 is hereby appropriated from the
7 Foreign Assistance Fund of the Kosrae State Treasury for the purpose of supplementing the
8 operation of certain governmental entities for the fiscal year ending September 30, 2007.

9 Section 2. Apportionment. The sum appropriated by Section 1 of this act is
10 apportioned as follows:
