A BILL FOR AN ACT

To amend the Title of State Law No. 9-33, by changing total amounts appropriated from United States Grant Fund and Revenue Fund to reflect the actual total appropriation; and to amend Section 3, and Section 4, to re-instate the line-item vetoed amount for operation of the Legislature; and amend a typographical error in Sections 11 and 12; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Purpose. The purpose of this amendment is to re-instate the line-item vetoed  
2 amount for the operation of the Legislature and to amend a typographical error in Sections 11  
3 and 12 of State Law No. 9-33.

4           Section 2. Amendment. Title Section of State Law No. 9-33 is hereby amended to read  
5 as follows:

6                   “To appropriate the sum of \$10,732,242 from the United States Grant Fund; the  
7 sum of \$1,924,563 from the Revenue Fund; the sum of \$982,579 from the Foreign Assistance  
8 Fund; and the sum of \$163,914 from the Airport Utilization Fund of the Kosrae State Treasury  
9 for the fiscal year ending September 30, 2008, for the purpose of funding the operations of all  
10 branches of the Kosrae State Government, its agencies, various programs, and infrastructure  
11 development projects; and for other purposes”.

12           Section 3. Amendment. Subsection 15 of Section 2 of State Law No. 9-33 is hereby  
13 amended to read as follows:

14                   “Section 2. Apportionment. Operation of the Executive. The sums appropriated  
15 by Section 1 of this act are apportioned as follows:

16                   “(15) Department of Transportation & Infrastructure

1 Section 4. Amendment. Sections 3 and 4 of State Law No. 9-33 are hereby amended to  
 2 read as follows:

3 “Section 3. Appropriation. Operation of the Legislature. The sum of \$635,387,  
 4 or so much thereof as may be necessary, is appropriated from the Revenue Fund of the Kosrae  
 5 State Treasury for the operation of the Legislature for the fiscal year ending September 30, 2008.

6 Section 4. Apportionment. Operation of the Legislature. The sums appropriated  
 7 by Section 3 of this act are apportioned as follows:

8	(a)	Personnel	-0-	439,037	-0-
9	(b)	Travel	-0-	80,000	-0-
10	(c)	Contractual	-0-	39,600	-0-
11	(d)	Others	-0-	66,750	-0-
12	(e)	Fixed Assets	-0-	10,000	-0-“

13 Section 5. Amendment. Sections 11 and 12 of State Law No. 9-33 are hereby amended  
 14 to read as follows:

15 “Section 11. Appropriation. The sum of \$4,035,258, or so much thereof as may  
 16 be necessary, is appropriated from the United States Grant Fund; the sum of \$80,000 is  
 17 appropriated from the Revenue Fund of the Kosrae State Treasury for the purpose of funding  
 18 certain Governmental programs, grants, and contributions for the fiscal year ending September  
 19 30, 2008.”

20 Section 12. Apportionment. The sums appropriated by Section 11 of this act are  
 21 apportioned as follows:

22	(1)	Retirement Pension Program	-0-	80,000
23	(2)	Infrastructure Development Projects	2,625,807	-0-
24	(3)	Private Sector Development Projects	483,460	-0-
25	(4)	Capacity Building Project	175,991	-0-
26	(5)	Kosrae Adjustment Program	750,000	-0-“

1           Section 6. Effective Date. This act takes effect upon the approval of the Governor or  
2 upon its becoming law without such approval.
